### 3. Description

Class B rescue lifting device, with an additional lowering function, in 220 galvanized steel wire rope, diameter 4,9mm, construction 7x19, working length: 18m. On wire rope end, a thimble loop including an energy absorber. Energy absorber with polyamide and polyester tear webbing, width 45mm, ended by a sewn loop, protected by heat-shrinkable sheath, and integrating a connector, reference M47, with swivel function, and automatic locking gate device by safety catch. On the housing side, a plate for mounting the bracket, reference 210208, in S235 steel, for use with the type A anchor devices EMBASE AU SOL + MAT DAVIMAST + CONSOLE DAVIMAST, EMBASE EN APPLIQUE + MAT DAVIMAST + CONSOLE DAVIMAST, EMBASE MURALE DEPORTEE + MAT DAVIMAST + CONSOLE DAVIMAST and EMBASE ENCASTREE AU SOL + MAT DAVIMAST + CONSOLE DAVIMAST, complying with EN792:2012. Exclusive vertical use. Maximum rated load: 150kg (detailed in the conformity report n°21.0118).

### 4. Technical referential

The assessment of conformity was conducted taking into account the provisions of European standard EN 1496:2017 "Personal fall protection equipment – Rescue lifting devices".

### 5. Conditions for use

This class B rescue lifting device is intended to be used, together with other components, as personal protective equipment against falls from a height planned for the rescue operation.
