


# Product description "SLING-11"


The anchor device "SLING-11" has been developed as a fastening point for securing a person and is intended for installation on a statically load-bearing wooden substructure or on a concrete structure.

### System construction

It is to be attached to a rafter substructure (mounting rafters) with a cross-sectional dimension of at least 100 mm x 120 mm or a rafter substructure (fixing rafters) with a cross-sectional dimension of at least 80 mm x 80 mm plus a full formwork at least 20 mm thick and a counter slating of at least 40 mm x 40 mm.




For mounting the SLING-11 in a wooden construction, HBS wood construction screws with a diameter of 8 mm and a length of  $\geq$  120 mm are recommended. Since different lengths of the fastening screws are required depending on the roof structure, the mounting rafters should have a minimum penetration depth of 80 mm (minimum length of thread).







Concrete screws of the "HILTI" brand, type "HUS3-H 8x65 15/5/-" shall be used for the installation of the SLING-11 in a concrete structure (minimum quality C20/25) with a minimum thickness of 100mm. The minimum distance to the edges on all sides shall be 300 mm.

- other defects are found (loose screw connections, deformations, corrosion, wear, ...).

After each disassembly of the INNOTECH "SLING-11" the anchor device (incl. screws) must be checked for damage (wire breakage, deformations, etc.).

The operational capability of the entire securing system shall be checked by comparing it with the acceptance protocol and the test protocol.
