Official Company Statement for



To all concerned customers

We understand your concerns about ingredients included in e-liquid products, and we are more than happy to answer any questions you may have.

All Light Your Fire products manufactured by Concept Liquids Limited are registered on the EU/CEG system which is overseen by the European Tobacco Product Directive. This means that all liquids have been strictly chemical tested and have been approved for sale and each have their unique EC-ID's which means they are legally sold in the European Union and overseas.

All Light Your Fire products manufactured by Concept Liquids Limited have none of the following substances:

From TPD law:

- any ingredient that poses a risk to human health in heated or unheated form
- vitamins or other additives that create the impression that a tobacco product has a health benefit or presents reduced health risks;
- caffeine or taurine or other additives and stimulant compounds that are associated with energy and vitality;
- additives having colouring properties for emissions;
- additives that have carcinogenic, mutagenic or reprotoxic (CMR) properties in unburnt form.

From national UK standards:

- Substances classified as carcinogenic, mutagenic or reprotoxic (CMR categories 1 and 2)
- Substances classified with specific target organ toxicity for the respiratory tract (STOT category3 1)
- Respiratory sensitizers
- Vitamins used as food supplements
- Stimulant additives such as caffeine or taurine
- Diacetyl
- Pentane 2,3 dione
- Diethylene glycol
- Ethylene glycol
- Formaldehyde
- Acetaldehyde
- Acrolein
- Metals, including cadmium, chromium, iron, lead, mercury and nickel
- Preservatives liable to release formaldehyde.

Finally, apart from the extensive GC-MS and TD-GC-MS analyses done on the liquids, and also Emission Testing of the actual vapor produced, we also have done chemical analyses to ensure our liquids are free from TSNA's. All these analyses are registered on the central European EU/CEG database and have been approved by the relative authorities.

We do understand your concern about knowing what you are vaping, and you can rest assured that our liquids are of the highest quality, made with Pharmacopeia grade ingredients, produced in our own laboratory in certified Cleanrooms and are all made under an ISO:9001 BSI certified production procedure. Specifically about the health problems of vapers in the USA, all available information indicates that these individuals were vaping THC oil (cannabis oil) and also some of the oils had added Vitamine E Acetate. Vitamine E Acetate is an additive used in the skin product industry, and has nothing to do with vaping. Illicit e-liquid manufacturers in the USA added it to cannabis liquids for vaping because it makes the cannabis oil thicker and easier to vape.
