SECTION 4. First aid measures

4.1. Description of first aid measures

8.2. Exposure controls

RESPIRATORY PROTECTION If the threshold value (e.g. TLV-TWA) is exceeded for the substance or one of the substances present in the product, use a mask with a type A filter whose class (1, 2 or 3) must be chosen according to the limit of use concentration.
